Subject: Creation of 25 temporary posts of Helper in the Forest Department (Territorial).  
Reference: 11<sup>th</sup> Meeting of the Empowered Committee held on 13-09-2017 received vide O.M. No. A/54(2015)-167 dated 15.11.2017 from the Finance Department.

In pursuance of Rule 3 of J&K Daily Rated Workers/Work Charged Employees (Regularization) Rules, 1994, sanction is accorded to the creation of 25 (Twenty five) temporary posts of Helper in the pay scale of Rs. 2550-3200 (pre-revised) for regularization of equal number of Daily Rated Workers of Ramban Forest Division, whose names are given in annexure "A" to this Government Order with effect from the dates shown against each, subject to the fulfillment of following terms and conditions:-

1. The regularization order of Daily Rated Workers shall be issued by the Principal Chief Conservator of Forests J&K, subject to the fulfillment of following terms and conditions :-
  - a) That the Genuineness of MRs /engagement orders is verified /certified by the concerned DDO/ HoD.
  - b) That he is a Permanent Resident of the State of Jammu and Kashmir.
  - c) That on the date of his initial appointment, his age was within the minimum and maximum age limit as prescribed for appointment in Government Services;
  - d) That he is not retiree from any State or Central Government service or any Local Body, Public Sector Undertaking or Autonomous Body in or outside the State;
  - e) That his work and conduct has remained satisfactory during the period he worked as Daily Rated Worker and no disciplinary proceedings are pending against him.
  - f) That he has continuously worked in the Department from prior to 31-01- 1994 till date and fully qualify as per SRO-64 of 1994;
  - g) That no enquiry/investigation i.e. departmental or in Vigilance Organization / Crime Branch / Police Station is pending against the incumbent.
  - h) That the incumbents have been paid wages as per notified rates which shall be established/certified by the concerned HoD). /

- i) That the incumbents fulfill all the terms and conditions as laid down in SRO-64 of 1994 and conditions mentioned in record note of 11th meeting of Empowered Committee held on 13-09-2017
2. The PCCF shall ensure that eligibility criteria for regularization as per SRO-64 of 1994 is strictly established and complete original record and bio-data is verified in respect of each DRW and in case any DRW fails to fulfill the required terms and conditions, the HOD shall convey the same to Administrative Department. If the DRW regularized by the HOD, at a later stage found with any of the deficiency, the whole responsibility shall lie upon the HoD concerned and further legal action under law / rules will be initiated against the said officer.
  3. The posts so created shall not be utilized except for the purposes for which it has been created.
  4. The posts so created shall get reduced as and when the existing incumbents vacate the posts by way of termination / retirement / death. The Budget provision under the wages component shall be correspondingly reduced in the current year's Budget of concerned Divisions.
  5. The utilization certificate of the posts approved shall be made available to the Administrative Department within one month from the date of issue of this order.
  6. Arrears from date of regularization to the date of issue of regularization order shall be paid in five equal annual installments after projecting the same under Annual Budget Estimates of the Department.
  7. The cases involves relaxation in age/qualification bar should be established by the PCCF, J&K and refer to the Administrative Department for further necessary action.
  8. The PCCF shall issue regularization order after fulfilling the conditions prescribed in the minutes of the meeting and as per all terms and conditions laid down in the SRO-64 of 1994, and also conditions laid down in the 11th meeting of Empowered Committee held on 13.09.2017 in respect of late Sh. Suram Chand S/o Mohar. Singh R/o Karol Ramban figuring at Sr. No. 66 and the directions issued by the Administrative Department from time to time.

**Sanction is also accorded to the qualification bar/upper/lower age bar in respect of Sr.No.2,6,9,11,12,16,17,18,20 & 24 mentioned in the Annexure "A" of this Government order ,in terms of Rule-4(c) of Jammu and Kashmir Daily Rated Worker's (Regularization ) Rules notified vide SRO-64 of 1994 dated 24-03-1994.**
