Subject:- IWDP Manpower and Assets- Proposal for proper utilization.

Government Order No. 68 -JK(FST) of 2021
Dated. 14 .06.2021

Whereas, vide Government Order No. 370-FST of 2018,dated 03.12.2018, a High Level Committee was constituted to work out the modalities for transfer of movable/immovable infrastructure of erstwhile IWDP, including the issue of fixation of seniority of the IWDP borne staff, deployed in various wings of the Forest, Ecology and Environment Department; and

Whereas, it was observed that said Committee was designated by name and, as on date, some of these officers included in the said Committee have been transferred while some have retired or relinquished the charge; and

Whereas, this state of affairs has resulted in the said committee becoming obsolete as no meeting could be held thereafter; and

Whereas, this necessitates re-constitution of the said Committee to address the issues, arising out of winding up of Integrated Watershed Development Programme (IWDP) in a time bound manner.

Now therefore, in partial modification of Government Order No. 370-FST of 2018, dated 03.12.2018, sanction is hereby accorded to the re-constitution of High Power Committee, comprising the following to work out the modalities for transfer of movable/immovable infrastructure of erstwhile IWDP, including the issue of fixation of seniority of the IWDP- borne staff, deployed in various wings of the Forest, Ecology and Environment Department. However, the other terms and conditions shall remain the same.
