Regarding extraction, following shall be the procedure :

- The extraction of the trees/poles/saplings shall be done by the J&K Forest a) Development Corporation/Divisional Forest Officer concerned on the basis of markings administratively approved by the competent authority. The marking for tree felling will be done in consultation with the user agency and effort shall be made to save maximum number of trees/poles/saplings. The cost of extraction shall be paid by the user agency directly to the agency executing the extraction.
- b) The fundamental rule for marking of trees, enumerated during processing of the proposals, will be to save maximum number of trees without compromising with the construction and maintenance of the approved project structure and no trees/poles/saplings will be felled/cut/pruned/lopped for purposes/project activities other than those approved/sanctioned.
- No damage will be done to the adjoining forest land and all efforts shall be made to save the v. adjoining forest and forest land.
- The User Agency shall obtain Environmental Clearance as per the provisions of the vi. Environmental (Protection) Act, 1986, and any other clearances under relevant Acts/ Rules/court's Rulings/instructions, etc., as applicable to this proposal
- The forest land so allowed for use shall return to the Forest Department free of any vii. encumbrances when it is no longer required by the User Agency.
- Any other condition that MoEFCC or its Regional Office may stipulate, from time to time, in viii. the interest of conservation, protection and development of forests & wildlife.
