Sanction is hereby accorded to the temporary appointment of Mst. Afroza Bano W/o Late Mohammad Aslam Najar (Ex. Sr. Driver), R/o Hamdania Colony Bemina Tehsil & District Budgam as Class-IV (Watcher) in the pay level of SL-I (14800-47100) in Forest Protection Force in District Cadre Srinagar in relaxation of the prescribed qualification bar in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to Director, Forest Protection Force, J&K within a period of 21 days from the date of issuance of this order and shall be allowed to join only on the production of following documents/certificates (in original) to be verified subsequently:-

1. **Academic Qualification Certificate.**
2. **Date of Birth Certificate.**
3. **Permanent Residence Certificate/Domicile Certificate.**
4. **Health Certificate from the concerned Chief Medical Officer of the District.**
5. **Dependent Certificate issued by the Assistant Commissioner, Revenue.**
6. **No Loan Certificate under Self-Employment Scheme from DIC concerned and Employment Department.**
7. **All other relevant documents as are required under SRO-43 of 1994.**

The appointment of the appointee shall further be subject to the following conditions:-

(a) That she shall give an undertaking in the shape of an Affidavit to the effect that:-

- (i) In case adverse report about her Character and Antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made by the General Administration Department, she shall have no right to claim her appointment as as Class-IV (Watcher) in the pay level of SL-I (14800-47100) in Forest Protection Force in District Cadre Srinagar and her appointment, as such, shall be deemed to have been cancelled ab-initio;

- (ii) If, on verification, genuineness of the qualification certificate from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV (Watcher) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.
- (b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (i) and (ii) above are received in her favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension scheme" as per SRO-400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within period of 21 (twenty one) days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
