Subject: - Request for permission to opening Sweep Account in J&K Bank and request for accord of sanction for advance drawl- regarding.

Reference:- PCCF/Plg/243-Part-III/2601-02 dated 13.08.2021.

Sanction is hereby accorded to the advance drawl of Rs. 25.72 crore (Rupees Twenty five crore, Seventy two lakh only) under Centrally Sponsored Scheme-Green India Mission revalidated/ authorized by Finance vide BEAMS Order No. 21/CSS/FDR/Resource-BE/2021-22/6/1 dated 15.06.2021 under Major Head 4406 & Sub Head 0200-Forest Territorial (Green India Mission) for its drawl by Principal Chief Conservator of Forests (HoFF), J&K for further disbursement/utilization as per the guidelines of the Scheme and subject to the following terms and conditions:-

1. CAO of PCCF(HoFF) Department shall vouchsafe the availability of funds under relevant classification on BEAMS.
2. That the funds are utilized as for the purpose for which these are approved by competent authority under the CSS- Green India Mission & there shall be no deviation of funds at all.
3. The funds shall be utilized after following all the required norms as provided in GFR-2017.
4. That the funds are not parked idle in the accounts.
5. That utilization certificate is rendered to the concerned quarters well in time.
6. Funds shall be transferred through State Nodal Account linked with the PFMS to ensure expenditure is reflected on the PFMS portal as well.
7. The UCs of present advance shall be furnished to the AGs Office under an intimation to Finance Department through administrative department within the stipulated time.
8. The expenditure shall be made on admissible items only as approved by the Competent Authority.
9. The expenditure shall be made after observing all the required codal formalities.
10. The UCs/ Red DC accounts shall not only be sought but invariably furnished to the concerned quarters within the stipulated time.
- 11 That PCCF (HoFF) shall open a separate Bank Account with J&K Bank Branch, moving Secretariat by freezing the existing account of Union Bank of India under this scheme and transfer the funds available in Union Bank of India to J&K Bank, moving Secretariat to make account operationilization.
