The appointee shall report to Principal Chief Conservator of Forest, J&K, within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

- i. Date of Birth Certificate.
- ii. Academic/Technical Qualification Certificates.
- iii. Health Certificate issued by an officer not below the rank of Chief Medical Officer.
- iv. Domicile Certificate.
- v. Relevant Category certificate (in case of candidates belonging to reserved categories).
- vi. Certificate from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
- vii. Any other certificate required under rules.

Salary of the appointees shall not be drawn and disbursed to them unless satisfactory report in respect of Qualification Certificate / Reserved Category Certificate is received.

The appointment of the candidate shall further be subject to the following conditions:-

- i. The candidates who fail to join within a period of 21 (Twenty one) days from the issuance of this order shall forego right to their appointment which shall be cancelled forthwith.

- ii. The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- iii. The appointees shall be on probation for a period of two years. If, on verification, the certificates produced by the appointee prove to be fake or forged, the appointment shall stand as cancelled ab-initio.
- iv. The probation of the appointee and Pay & Allowances during probation shall be regulated in terms of the provisions of the Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 dated 17.06.2020 read with J&K Civil Services (Classification, Control and Appeal) Rules 1956.
- v. The Cadres/Departments allocated to the candidate/s shall not be changed under any circumstances by any Authority/Department.
- vi. The appointments shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on he/she shall also be liable for criminal prosecution.
- vii. The appointment of the above candidates shall be subject to the final outcome of Writ Petition(s), if any, pending in any court of law.
- viii. The appointee shall furnish an undertaking as per the enclosed format.
