**Subject: Sanction of Leave Travel Concession (LTC) in favour of Mr. Vijay Bali, Section Officer (Extended Block Year 2020- 2023).**

**Sanction is hereby accorded to:-**

- I.** The grant of LTC w.e.f 08-06-2024 to 18-06-2024, in favour of Shri. Vijay Bali, Section Officer, to visit Himachal Pradesh (outside the Union Territory of J&K) along with his family , for the extended block year 2020-2023, in terms of Jammu and Kashmir Civil Services (Leave Travel Concession) Rules, 2019.
- II.** The grant of 05 days Casual leave wef 10-06-2024 to 14-06- 2024, prefixing 08-06-2024 & 09-06-2024 and suffixing 15-06-2024 to 18-06-2024, thus making whole period coterminous with the LTC, along with permission to leave the station.

*The sanction is however subject to the fulfillment of the following conditions:-*

- i.** The official or his dependents have not availed such concession earlier during the LTC block 2020-2023.
- ii.** The official shall submit final claim in Form-3 within one month from date of return from journey after availing LTC.
- iii.** The dependence of family members on the official is established under rules.
- iv.** For Journey to Himachal Pradesh, reimbursement will be regulated as per the shortest route.
- v.** The entitlement is regulated by the concerned Drawing & Disbursing Officer in terms of Jammu and Kashmir Civil Services (Leave Travel Concession) Rules, 2019 .
