Sanction is hereby accorded to the purchase of two No. troop carriers of mark TATA 407 Gold SFC DCR33HSD 100B6M5 BS-6 CAB and high deck load body with power steering PTOP (10.7 ft Deck length) for Gamma Unit J-01 flying squad Jammu and J-03 Kathua units of Forest Protection Force along with the release of Rs. 24.00 lakh (Rupees Twenty four lakh only) through BEAM5 under Detailed Head- 046-Purchase of Vehicle below Major Head 2406- Forestry and Wildlife and Sub Head 2175- Director Forest Protection Force and concurrence for advance drawl thereof in favour of Forest Protection Force, J&K

The Purchase is subjected to the following conditions:-

1. Purchase shall be made through State Motor Garages after fulfillment of all codal formalities.
2. The funds shall not be drawn just for idle parking in the bank account but incurred for the purpose these are authorized.
3. There shall be no appointment of driver and the department shall man the vehicles out of the existing staff.
4. The condemned vehicle, if any, be put to auction and auction proceeds remitted in Government Treasury.
5. Utilization certificate shall be submitted within the stipulated time to the concerned quarters under an intimation to this Department.
6. The vehicles shall be utilized for the purpose it has been sanctioned.
