Sanction is accorded to the Revalidation of an amount of Rs 10.1915 Crore (Rupees Ten crore Nineteen lakh Fifteen thousand ) only through BEAMS in favour of Chief Executive Director, Wullar Conservation & Management Authority (WUCMA) under 13th Finance Commission Award for its utilization during the current financial year, 2019-20 for conservation and Management of Wullar Lake against approved activities.

## The revalidation is subject to the following conditions:

- (i) The funds so revalidated shall be utilized only for specific purpose after observing all codal formalities including e-tendering, Administrative approvals and Technical Sanctions from competent authority wherever required;
- CED, WUCMA shall ensure that the works are taken up and completed within (ii) the approved cost.
- There shall be no overlapping of funds from any other source; (iii)
- The funds should not be parked un-necessarily; (iv)
- The funds so revalidated shall not be available for re-appropriation/diversion (v) at any level;
- The CED, WUCMA shall submit the utilization certificate of the funds released (vi) as early as possible and definitely well before 31-03-2020 to Administrative Department for its submission to GOI and State Finance Department;
- CED, WUCMA shall vouch safe the utilization of funds as per codal (vii) procedures/guidelines
- The funds shall be utilized for execution of the scheme strictly as per (viii) approved components.
