Sanction is hereby accorded to the reimbursement of medical expenses incurred by Sh. Haroon Chowdhary, Chowkidar on treatment of his wife Mtr. Marina Haroon at NH Narayana Institute of Cardiac Sciences Karnataka Bangalore in relaxation of Rule 6-A of the J&K Civil Services (Medical Attendance and Allowance) Rules, 1990, subject to the following conditions:

- i. Reimbursement of charges shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof shall be restricted to the extent of rates as applicable to such items/procedures at AIIMS, New Delhi.
- ii. All relevant medical bills/vouchers shall be got verified from relevant Medical Authority of the hospital where from treatment has been taken.
- iii. Essentiality certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- iv. Certificate from the Competent Medical Authority (Director Health Services/Principal GMC/other) is obtained to establish the genuineness of the treatment availed in the said hospital.

This issues with the concurrence of Finance Department conveyed vide U.O No: FD-Code/41/2021-03-1725 dated 02.12.2022 and followed by subsequent approval of the Competent Authority vide U.O No:- GAD-CORD/9/2023 dated 13.7.2023.


