**Sanction is hereby accorded to :-**

a) The purchase of six number (06) of vehicles & four (04) motor cycles against the replacement of condemned vehicles in favour of the Principal Chief Conservator of Forests (PCCF), J&K, under Detailed Head 046- Purchase of Vehicle, subordinate Major Head 2406-Forestry and Wildlife and Sub Head: 0349-Principal Chief Conservator and

b) Advance drawal of Rs. 63.00 lakh (Rupees Sixty three Lacs) only for purpose of purchase of these vehicles.

**The Purchase is subject to the following terms & conditions:-**

1. Condemnation of the vehicles is confirmed & sale proceeds shall have been remitted in the Treasury.
2. The drivers for plying these vehicles are available with the department and it should not involve creation of any post of driver(s).
3. The purchase of these vehicles is made through State Motor Garages Department.
4. The vehicles shall be purchased & put to use as per the existing car policy of the Government.
5. Red Account shall be submitted to concerned quarters within stipulated time period under an intimation to Admin Deptt.
