Post- facto sanction is hereby accorded to the reimbursement of medical expenses incurred by Sh. Manzoor Ahmad Hazari, I/C Deputy Inspector beyond Rs. 5.00 Lakh on his self treatment availed at Krishna Institute of Medical Sciences, Secunderabad Telangana in relaxation of rule 6-A of the J&K Civil Services (Medical Attendance-Cum-Allowance) Rules, 1990 subject to the following conditions:

- Reimbursement of charges shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof shall be restricted to the extent of rates as applicable to such items/procedures at AIIMS, New Delhi.
- All relevant medical bills/vouchers shall be got verified from relevant Medical Authority of the hospital where from treatment has been taken.
- Essentiality certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- Certificate from the Competent Medical Authority (Director Health Services/ Principal GMC/other) is obtained to establish the genuineness of the treatment availed in the said hospital.
- Follow up (if any), is regulated under rules.


