**The release/revalidation of funds is subject to the fulfillment of following conditions:**

- The expenditure shall be booked strictly as per approved Action plan and as per guidelines of the scheme prescribed by GoI;
- The expenditure shall be incurred after fulfilling all codal formalities;
- The funds so released shall not be available for re-appropriation/diversion at any level;
- The utilization certificate is furnished to the Administrative Department after expenditure is incurred and definitely before 31-03-2020 for its submission to Government of India/Animal & Sheep Husbandry Department;
- There shall be no overlapping of funding from any other source such as CSS/Flagship programme/ Capex Budget or any other source of funding;

- (vi) FA/CAO of Directorate of Pr. Chief Conservator of Forests, J&K shall vouchsafe the utilization of funds;
- (vii) The accord of Administrative Approval does not convey any sanction regarding act of appropriation unless specific allocation for the implementation of works/activities under the project is physically made available.
- (viii) While releasing the funds in favour of implementing officers, the Pr. Chief Conservator of Forests, J&K, Srinagar shall ensure that funds shall be released as per approved component wise break up wherein 10% State Matching Share shall be shown separately. A copy of the same shall be submitted to Administrative Department for monitoring purpose;
- (ix) The progress report both financial and physical shall be submitted to Administrative Department;
- (x) The implementing agency shall ensure that the expenditure as well as covering of the area has not already been covered/incurred out of any other scheme under Capex Budget or Non-plan Budget;
- (xi) The department shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending.
