In terms of Jammu and Kashmir (Compassionate Appointment) Rules, 1994, Sanction is hereby accorded to the appointment of Sh. Waseem Ahmad Parray S/o Lt. Ab. Gaffar Parray (deceased Helper) R/o Paner Jagir, Tehsil Tral Pulwama against the available Class IV post in the office of Director Ecology Environment & Remote Sensing under SRO-43 of 1994 in the pay scale of 4440-7440 +1300 (GP).

The appointee shall report to the Director Ecology Environment and Remote Sensing Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following certificates/documents.

- (i) Academic Qualification certificate.
- (ii) Age and Health Certificate.
- (iii) Dependent Certificate
- (iv) All other relevant documents as required under SRO-43 of 1994.
- (v) Certificate from General Manager, DIC concern and Deputy Director Employment concern to the effect that no loan under Self Employment Scheme has been taken.

If on verification, the certificates produced by the appointee are proved fake, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report about the verification of his character and antecedents is received from Inspector General of Police, CID, to whom a reference shall be made by the Director Environment and Ecology, J&K, Srinagar.
