Whereas, vide Government Order No..187-Fst of 2018 dated 07.06.2018, Shri T.B Singh, IFS (JK 2008) was ordered to report to PCCF and Mr. Vivek Verma IFS (JK 2010) was ordered to look after the charge of CF Chenab Circle Doda,

Whereas, Mr. T.B Singh, IFS (JK 2008), aggrieved by the said Government Order approached to the Hon'ble High Court Jammu through medium of SWP NO. 1265/2018 MP NO. 01/2018 titled Tej Bahadur Singh Vs State and others,

Whereas, the Hon'ble High Court stayed the said Government order so far it pertains to Mr. Vivek Verma IFS (JK 2010) and passed the following orders on 27.06.2018:-

Meanwhile, as ad interim, subject to objections and till next date before the Bench, impugned order dated 7/6/2018 (supra) to the extent of its item No. 2 whereby respondent No. 4 has been asked to look after the charge of CF Chenab Circle, Doda shall stay. Respondent No. 4 shall report to Administrative Department and it shall remain open for the Administrative Department to give him appropriate posting, having regard to his cadre position. In addition, the Administrative Department shall accord consideration to the representation of the petitioner in view of the averments made in this writ petition and shall intimate the decision taken to this Court along with their objections in the writ petition.

Petitioner shall provide a copy of this order along with a copy of the paper book of this writ petition in the office of the Administrative Secretary of the Administrative Department, herein respondent No. 1.

Whereas, the issue was examined in the Administrative Department and it was observed that transfer orders in respect of Mr. T.B Singh is premature at relevant point of time.

Whereas, keeping in view the interim order of Hon'ble High Court in the matter, the Government Order NO. 187-Fst of 2018 dated 07.06.2018 is modified as under:-

Sanction is hereby accorded to the following transfers:-

- 1 Mr Vivek Verma IFS (JK 2010) shall look after the charge of CF Working Plan.
- 2 Mr. Tej Bhadur Singh, IFS (JK 2008) shall continue at his previous place of posting i.e I/c CF Chenab Circle, Doda.

This arrangement shall not confer any prudential right to the officers for further promotion or regularization. Further it shall also not disturb over all seniority position of the officers.
