- I. The claim is covered under S.O 22 dated 03.12.2019.
- II. The officer or his dependents/family have not availed such concession earlier during the LTC block 2020-23.
- III. Entry to this effect is recorded in the Service Book of the officer.
- IV. The Dependence of family members on the officer is established under rules.
- V. Journey to Agra is performed by the shortest route.
- VI. The entitlement is regulated by the concerned Drawing & Disbursing Officer in terms of Jammu and Kashmir Civil Services (Leave Travel Concession) Rules, 2019.
- VII. Necessary provision of funds be made available under relevant object head of account.
- VIII. In case spouse of the official is in Govt Service, she can't claim the concession in her department for the instant block.
