## Functions & Mandate of Landscape level Coordination Committee:-

(i) The committee will have regular interactions with the village conservation committee in the planning, implementation and the monitoring of village micro-plans or Participatory Livelihood Management Plans that will lay out conservation, livelihood and wildlife crime prevention activities that will be funded by the project and complementary funding sources to improve the management of Himalaya landscape.

(ii) The State Landscape Planning and implementation team will co-opt block, district and sector staff and NGOs as relevant to facilities convergence of manpower, budgetary resources and

- technical support in the planning and implementation of village micro-planning activities so as to coordinate and maximize resources.
- (iii) The committee will also facilitate participation of these entities as relevant in the State Landscape Planning and Implementation teams to ensure convergence of manpower and financial resources. United Nations Volunteers will be placed at the District level as Community Mobilization Officer and Social Mobilization Officer.
