In terms of J&K Civil Services (Leave Travel Concession), Rules, 2019, sanction is hereby accorded to the grant of Leave Travel Concession (LTC) in favour of Sh. Mahesh Kumar, DFO, Forest Division Doda, to visit Goa alongwith his family, during the extended block year,2020-23, alongwith 08 (eight) days earned leave 09.12.2024 to 16.12.2024, with permission to leave the station.

The sanction shall be subjected to the following terms and conditions:-

1. The Officer or his dependents have not availed of such concession earlier during the Block 2020-23 extended to 2024.
2. Entry to this effect is recorded in the service book of the officer, as prescribed under relevant rules.
3. The entitlement is regulated under rules.
4. Journey to Goa is performed by the shortest route.
5. The necessary provision of funds is available under relevant head of account.
6. In case spouse of the officer being in Government Service, she can't claim the concession in her department for the instant block.

Further, it is hereby ordered that DFO, Demarcation Division-II, Bhaderwah shall hold the charge of the post of DFO Doda, in addition to his own duties, during the leave period of the aforesaid officer.
