Sanction is hereby accorded to the purchase of two units of Mahindra Bolero B4 BS-VI against the condemned vehicles for officers, Chief Conservator and Chief Account Officer of the Forest Department within available budget of Rs.16.00 lakh under Detailed Head- 046-Purchase of Vehicle below Major Head 2406- Forestry and Wildlife and Sub Head 0349-Principal Chief Conservator along with advance drawal thereof in favour of PCCF(HoFF), J&K .

The Purchase is subjected to the following conditions:-

1. That there shall be no appointment of driver and the department shall man the vehicles out of the existing staff.
2. That the condemned vehicles are got auctioned and proceedings thereof shall be remitted into Govt. Treasury under intimation.
3. That the officers using these vehicles are covered under car policy.
4. Purchase shall be made through State Motor Garages subject to standard terms and conditions as per codal procedure.
5. The funds shall be not be drawn just for idle parking in the bank account but incurred for the purpose for which authorized by Finance Department.
6. The vehicles are deployed for the purpose for which purchased.
7. Utilization certificate shall be submitted within the stipulated time to the concerned quarters under an intimation to this Department.


