Sanction is hereby accorded to the purchase of six troop carriers of mark TATA 407 Gold SFC DCR33HSD 100B6M5 BS-6 CAB and high deck load body with power steering PTO (10.7 ft Deck length) along with relaxation for incurring expenditure in last month of the current financial year within available budget of Rs.66.90 lakh under Detailed Head- 046-Purchase of Vehicle below Major Head 2406- Forestry and Wildlife and Sub Head 2175-Director Forest Protection Force along with advance drawal thereof in favour of Forest Protection Force, J&K

The Purchase is subjected to the following conditions:-

1. Purchase shall be made through State Motor Garages after fulfillment of all codal formalities.
2. The funds shall not be drawn just for idle parking in the bank account but incurred for the purpose they are meant for under rules.
3. That there shall be no appointment of driver and the department shall man the vehicles out of the existing staff.
4. The vehicles are deployed for the purpose for which purchased.
5. Utilization certificate shall be submitted within the stipulated time to the concerned quarters under an intimation to this Department.


