Mohandas, IFS, the then Conservator of Forests, East Circle, Jammu {now Conservator of Forests (Wildlife), Jammu}, w.e.f. 21.11.2023 to 05.12.2023, along with 10 (Ten) days' leave encashment benefits, for the block year 2022-23, subject to the fulfillment of the following conditions:-

1. The claim is covered under Central Civil Service (LTC) Rules, 1988.
2. The officer or any of his dependents has not availed such concession earlier during the LTC block 2022-23.
3. The leave applied for by the officer is sanctioned by the competent authority.
4. Entry to this effect is recorded in the service book of the officer.
5. Journey to Ooty, Tamil Nadu is performed by the shortest route.
6. The entitlement is regulated by the concerned Drawing & Disbursing officer under rule.
7. Fulfillment of economy measures notified vide Finance Department's Government Order No.17-FD of 2024 dated. 15.01.2024.
