Whereas, the General Administration Department vide OM No. GAD(Vig)25/-SP/2019 dated 07.10.2020 furnished a list of 24 in service public servants for commission of offences punishable U/S 5(1)(c)(d), r/w 5(2) of the prevention of Corruption Act, Samvat, 2006 and Section 120-B, 468, 471 RPC in case FIR No. 23/2011 P/S Vigilance Organization, Kashmir (now ACB).

Whereas, the case was registered against these employees in the year 2011, so the confirmation about the present posting and status of the public servants was sought from the Divisional Forest Officer, SC&FC Division Pohru, Langate.

Whereas, as per the list furnished by the DFO, SC&FC Division Pohru, Langate, three (03) employees have retired from the service and one has expired, as such, the CCA Rule -31 can't be invoked against the retiree/deceased employees.

Now, therefore, pending enquiry into their conduct, the below mentioned delinquent officers/officials of the Department of Forest, Ecology & Environment are hereby placed under suspension with immediate effect in terms of Rule-31 of J&K Civil Services (Classification, Control & Appeal) Rules, 1956:-
