The project implementing division shall submit monthly, quarterly and annual physical and financial progress reports along with visual clips/ contour mapping/ structural design of the site and GPS photographs of each patch of the work before, during and after treatment to the Chairman of the Committee and to the Administrative Department as well.

The Committee shall meet regularly, assess the progress and report to the Authorities. Besides, internal monitoring shall be done by the concerned Divisional Forest Officer, Conservator of Forests and Chief Conservator of Forests.

The financial auditing of the project works shall be done by the Chartered Accountant (CA) who is on the panel of the C&AG. Moreover normal audit shall be conducted by the concerned authority (Accountant General).
