The committee shall submit a report into various allegations into the illegal cutting/felling of Khair Trees after hearing the complainants, examining all the relevant record, including that pertaining to the previous Kahir Cutting permissions and Forest/revenue record demarcating the Forest Boundary, inspect and demarcate the site.

Revenue officials of Jammu District will be associated for clear demarcation of the areas. The committee may also co- opt any other officer/official, as may be required.

The committee shall submit its initial report within a period of 15 days and the final report within a period of 30 days from the date of issue of this order.
