Subject: - Release of Grant-in-Aid.

Government Order No.:- 9 -JK(FST) of 2021
Dated :- 30.01.2021.

Sanction is hereby accorded to the advance drawl of Rs. 50.00 crore (Rupees Fifty Crore only) as Grant-in-Aid under Detailed Head 028-Grant-in-Aid below Major Head 2406 and Sub-Head 1312-Grant to State Forest Corporation by the Forest, Ecology and Environment Department for its further placement with Managing Director, J&K Forest Development Corporation to meet out the pending salaries of its employees as first charge and remaining amount for clearance of other committed expenses. The sanction is subject to the following terms and conditions:-

1. The funds shall be utilized for clearance of pending salaries of employees as first charge and remaining amount for clearance of other committed expenses after following all the required codal formalities.
2. The UCs of present advance and previous advances shall be furnished to the AGs Office under an intimation to Finance Department through administrative department within the stipulated time.
3. The Forest Development Corporation shall update salary of the employees and in no case shall create any liability
4. FACO/CAO of J&K Forest Development Corporation shall vouchsafe the availability of funds for the purpose.
5. The expenditure shall be made on admissible items only as approved by the Competent Authority.
6. The expenditure shall be made after observing all the required codal formalities.
7. The UCs/ Red DC accounts shall not only be sought but invariably furnished to the concerned quarters within the stipulated time.
8. The corporation shall remit all the revenue accrued immediately into the Government account and remittance shall be made instantly in terms of Rules in vogue.
9. The budgetary support is based on performance i.e the Corporation will ensure that it does not become a burden on the Government exchequer.
10. Further release of Grant-in-Aid is subject to furnishing of UC of previous releases and submission of Red DC account thereof to this Department.


